[BACKGROUND at this last meeting after the referendum signature drive.

The Council introduced these Ordinances at their meeting on December 10, 2013 and adopted them at their meeting on January 14, 2014.

At their meeting on January 28, 2014, the Council heard public concern over the Ordinances and that the circulation of a referendum petition to require the City to submit the Ordinances to a vote of the people had been initiated. An election on such a referendum would not only be expensive, it also would unnecessarily divide the community.

To avoid the negative impacts created by the concerns and disagreements among residents, and to avoid the City absorbing the expense of referendum proceeding to submit the Ordinances to the voters, the Council finds that it is in the best interests of

the City and its residents to repeal the Ordinances and reopen the review process to encourage an even broader community involvement and attempt to find new alternatives addressing most if not all concerns of the public.

The repeal of Ordinance No. 2014-1 and Ordinance No. 2014-2 will have the effect of reinstating existing regulations codified in St. Helena Municipal Code Chapters 17.180 and 17.120.]
